# myfood24 privacy notice

### 1. Purpose of this notice

This notice tells you how your personal information will be collected and processed when you access and use this website. We take your privacy very seriously and we ask you read this privacy policy carefully as it contains important information on the personal information we collect about you, what we do with your information and who your information might be shared with.

#### 2. Who we are

This website is owned by Dietary Assessment Ltd and our registered office is at 11/75 EC Stoner Building, University of Leeds, Leeds LS2 9JT ("We" or "Us").

### 3. myfood24 tool

We are primarily a data processor for the purposes of the General Data Protection Regulation 'GDPR' (the "Legislation")

We will only be a data controller in respect of your personal information if you:

- are a researcher, teacher or dietitian / clinician (i.e. a customer of Dietary Assessment Ltd and the registered "Administrator" for your organisation's use of myfood24) and are accessing this website, in which case you / your organisation will have a contract in place with Dietary Assessment Ltd.
- contact us via this website through the 'Contact Us' form or via registering to use the 'Demo' facility.

Whether acting as a data processor or a data controller, we will take all reasonable steps to ensure we comply with the Legislation.

For customers contracted to use myfood24, we are the data processor where you, acting in your capacity as an Administrator, are using myfood24 to collect dietary information from participants and patients ("End Users").

Each End User has a designated Administrator who will be managing a research, health or teaching project/study. The Administrator will have obtained consent (the legal basis of our processing) from the individual End User to collect their dietary information. How this information will be used will have been detailed in a Participant Information Sheet or similar provided to the End User by the Administrator. Where required, the Administrator will also have received approval for their study from the relevant ethics committee of their respective institution or similar.

#### 4. What Personal information is collected?

### **Administrator**

In order to create a project/study in myfood24 you will have provided us with your name and work email address and consented to us holding your personal information.

#### **End User**

Please note: An End User is not under statutory or contractual obligations to provide personal data to us.

In order to have received a myfood24 invitation email and gained access to the myfood24 tool you will have already provided your Administrator with your name and email address and consented to them and to us holding and processing this personal information. All further information (age, sex, diet) is optional.

If you received an invitation but you had not consented to this please contact the Administrator who originally contacted you, or if you are unable to contact them please use the contact information at the end of this privacy notice.

We may use your personal information to contact you regarding changes to myfood24 while you are an End User.

We may use your aggregated and anonymised results for our administrative purposes; our other services and for the purpose of ongoing development and improvement of myfood24. No personal data identifying you shall be retained.

This website is hosted on servers located in Amsterdam and operated by DigitalOcean of New York. For information on what Digital Ocean records as a result of you using this website please refer to their legal information or <a href="http://www.digitalocean.com/legal/data-processing-agreement/">http://www.digitalocean.com/legal/data-processing-agreement/</a>.

### 5. Third-party access

Your personal information will not be sent to other third-parties unless you are first notified and give your further consent.

#### 6. Cookies

Cookies are small text files that are placed on your device by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.

We do not use cookies to collect personal information about you. Should you wish to restrict or block cookies which are set by our website you can do this through your browser settings. The 'help' function within your browser or the manual that comes with your device should tell you how. ## 7. Automated collection of personal information

This notice and therefore the ways in which your personal information may be processed can be changed from time to time. Any changes will only be notified via this web page.

## 10. Your rights as a data subject

Under the Legislation you have the right to:

- withdraw consent;
- access your personal data that we process;
- rectify inaccuracies in personal data that we hold about you;
- be forgotten, that is your details to be removed from systems that we use to process your personal data;
- restrict the processing in certain ways (we are permitted to store the personal data, but not use it);
- obtain a copy of your personal data in a commonly used electronic form; and
- object to certain processing of your personal data by us:
  - o processing based on legitimate interests or the performance of a task in the public interest/exercise of official authority
  - o direct marketing
  - o processing for purposes of scientific/historical research and statistics

## Administrator

On expiry of your licence to use myfood24, your account will be made inactive, but your name, email address and work organisation will be kept for a period of 6 years from the expiry of your licence for HMRC purposes

#### **End User**

Administrators are responsible for the deletion of End User name and email addresses on completion of the project/study and before the expiry of your licence (when access to the myfood24 tool will cease). In any event, even if the Administrator fails to delete the End User personally identifiable data, it will be deleted by the myfood24 system after a maximum of six years from the expiry of your licence.
